What a year for Beth Donovan Hospice! Last March we purchased our Forever Home at 1107 French Settlement Road. We began construction in September and moved our offices in as part of Phase 1 in January and continued with construction in Phase 2, and in March moved all of our programs and services under one roof. With the addition of 2 fire exits, walls, flooring, electrical and drywall, we met all requirements to finally realize our dream.

This past year we welcomed the addition of a new fundraiser the Hospice Hoedown held in Merrickville which raised over \$38,000 in its first year! Many service clubs continued their long standing support of the Hospice along with business and individual donors contributing over \$100,000 in fundraising and donation revenues for the fiscal 2016/17.

In June we said goodbye to Dawn Rodger our former Executive Director of 8 years and wished her well on her new career path. In July we welcomed Debbie Watt as our new Executive Director bringing her many years of palliative and nursing experience to our hospice.

The thousands of hours of donated volunteer time in administration, transportation, Day Hospice, In Home Visiting, Board and maintenance make our hospice what is today. We could not continue to offer the high quality programs and services with the dedication of our hundreds of volunteers.

We look forward to what the future holds for Beth Donovan Hospice and are excited to be in our new forever home. We will continue our quest to secure funding and approval for residential beds and thank each and every member of our community for your continued support.

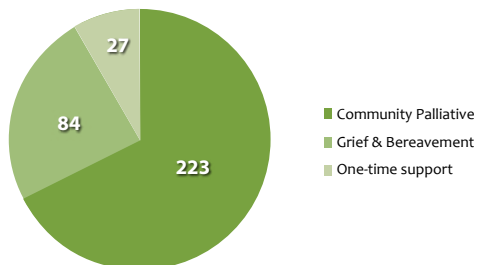

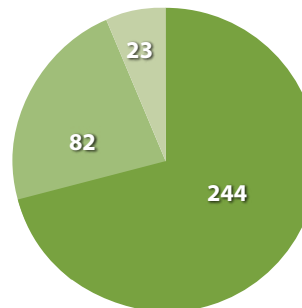
